Conditions:

- ◆ Traveling expenses are not included in the package price and are billed directly to the customers. A basic fee of \$20 is charged for each visit + 0.35 \$ /Km of distance covered. These amounts are not included in the packages.
- ◆ Hotel and living expenses will be charged if applicable.
- ◆ Travel expenses of 30 \$/h will be charged for consulting in more remote regions. These regions include the following: Abitibi, Bas-Saint-Laurent-Gaspésie, Saguenay-Lac-St-Jean, Charlevoix, Hautes-Laurentides, Outaouais and Côte-Nord.
- ◆ For those regions where travel by plane is more economical, air transportation will be billed.
- ◆ A minimum of 15 minutes of service is billed for each telephone intervention and a minimum of 60 minutes for each visit.
- ◆ The hours included in specific package are not exchangeable for another type of consulting service (technical or agro-environmental).
- ◆ Unused hours from a package can be accumulated over a period of 15 months from the date of registration but cannot exceed 16 hours for the technical packages and 40 hours for the Agro-environmental Club package.
- ◆ All rates are in Canadian dollars and are valid only for businesses in Quebec. For businesses outside Quebec, please contact IQDHO for fees. Taxes may vary between states, provinces or countries and will be added accordingly to the fees.
- ◆ Interest rates of 1.5% per month (annual compound interest rate of 19.56 %) will be charged after 30 days.
- ◆ The R&D consulting services can include support for R&D tax credit claims. IQDHO will fill the claims in a diligent manner and to the best of their ability based on the information provided by the customer. However IQDHO offers no warranty that the customer will be entitled to any tax credit or exemption from the Federal or Provincial government as applicable.
